Baths are done the day before your pet is going home unless otherwise specified to our receptionist. If you would prefer you pet to be bathed on the day it is going home, please pick up after 3pm to ensure they are ready to be taken home.

Teeth Brushing-for pets that get their teeth brushed at home we can continue their routine **Y or N 12.75/daily**

This is not a dental cleaning and owner must pack their pet's toothbrush and toothpaste

Lodging Rules and Regulations

Please read & check each box, by checking the box you are indicating that you have read and understand each item.

- Lodging fees are based on date to date, this means you are charged the day you drop off and the day you pick up. Exp. Friday to Sunday = 3 days of lodging. If you pick up before 10am Monday thru Saturday you will not be charged for the day of pick up, on Sunday it is 12pm. Open ended lodging reservations or reservations over 2 weeks will result in a deposit at the time of drop off and you must leave a credit card number on file that will be charged weekly.
- For the protection of your pet, every pet must be up to date on vaccinations **PRIOR TO LODGING**. If Limerick Veterinary Hospital is not your vet, written proof needs to be faxed 610-489-0618 or emailed records@liverickvet.com from your vet.

For canine lodging we require:

Current exam

Rabies (by law)

Distemper (DHPP)

Bordetella (Every 6 Months)

Bivalent Influenza Vaccine (Every 12 months)

Fecal sample tested with the last 12 months (Must be negative).

Current dog license or a lifetime license.

- I understand that even if my pet is fully vaccinated there is a chance that my pet can still contract an infectious respiratory disease such as Kennel Cough. I agree that I will not hold Limerick Veterinary Hospital responsible
- If your dog's fecal sample is positive for a parasite, they may not have group playtime until the veterinarian allows it. If a fecal sample is being tested during your pet's stay and the results come up positive for parasites, medication will be prescribed and administered at the owner's expense.
- Any pet that lodges in Happy Tails is subject to a one time per stay Hazardous Waste Disposal Fee of \$9.25.
- Baths will be given at the owner's expense if your dog becomes overly dirty during his/her stay with us.
- Medication may not be hidden in your pet's food. Our staff needs to be aware of all medications our guests are taking, and we want to ensure each pet is taking their medication. If medication is found in your food you will be charged a one-time fee of \$25.00 plus the dispensing fee is needed below
Once Daily: \$5.50 Twice Daily: \$10.00 Three times Daily: \$13.50 Four times Daily: \$18.25
- If your pet arrives with fleas and/or ticks he/she will be bathed and treated with a flea and tick product at the owner's expense. All means to contact you will be conducted and pet might be able to stay.
- A charge will be applied to each day of lodging for any pet that requires special handling due to temperament or has special needs due to medical problems. This is determined by management and your pet might not be able to stay.
- If any medical condition develops during your pet's stay with us, our medical staff will attend to it, that may result in additional charges to your bill. All means to contact you in this situation will be conducted.
- We DO NOT allow leashes, collars, harnesses, gentle leader, beds, blankets or toys to be brought from home. We will provide fresh clean and soft bedding daily along with toys for your pet during his/her stay with us. We WILL allow some items needed for medical conditions, such as slings, diapers or Martingale collars.
- Prices may change without prior notice.
- All charges are due upon release from the Facility.**

- If the pet is not called for within Five (5) days after the time specified for return, and if the office is not notified in writing of an alternate date within the five-day period, the animal will be considered abandoned, the hospital may handle this abandonment in a manner that is in the best interest of the pet and hospital. It is understood that this does not relieve me from paying for all costs of your services and use of your hospital including the cost of boarding. Should it be necessary to assign this account to a licensed collection agency or attorney, the applicant agrees to pay all subsequent collection and/or legal fees.
